

# Student Selection for Membership

- Nominations from peers with input from faculty and residents
- Selected by GHHS committee
- 15% of the class selected at the end of the clerkship year



# Class of 2023 Selection Process

- Rising fourth-year class is invited to nominate their peers via a GHHS survey, designed around the tenets of GHHS
- Faculty is invited to nominate rising 4<sup>th</sup> year medical students to help further inform peer nominations.
- Survey scores compiled and presented to a Selection Committee, composed of Larner GHHS members (faculty, M4 students, and local physicians and residents)
- Approximately 15% of the rising fourth-year class selected for induction

1. The classmates you would like to have at your side in a medical emergency
2. The classmates who best personify the quote "The secret of good patient care lies in caring for the patient"\*
3. The classmates who have shown exceptional interest in service to their communities

5. The classmates you would want as the doctor for yourself or a loved one\*
6. The classmates who have the best listening skills with patients\*

- Cross-sectional study of 50 384 medical students at accredited US medical schools from 2016 to 2019
- Published in 2022, it is the first study to look closely at Gold Humanism Honor Society membership in medical schools across four categories – race/ethnicity, sex, sexual orientation, and childhood family income.
- Disparities in GHHS membership sometimes favored the marginalized group and **no cumulative disadvantage was seen for students with multiple marginalized identities.**

## National and Chapter Awards

- **Leonard Tow Humanism in Medicine Award** recognizes students and faculty members who demonstrate both clinical excellence and outstanding compassion in the delivery of care. Faculty & students who are selected for the award become GHHS members if they were not already in the membership. These are Chapter level awards.

# Overview of Class of 2023 Medical Student Eligibility and Selection

- Eligibility
  - Top 25% of class eligible for election
  - Based on clerkship distinction calculation
- Selection Process
  - Eligible students invited to submit an application
  - Application process reviews achievement based on:
    - Leadership
    - Scholarship/Research
    - Humanism
    - Service
  - AOA Selection Committee then selected up to 20% of the class for AOA induction in early-August

## Class of 2023 Medical Student Eligibility and Selection

- Top 25% of students identified based on merit who demonstrated the characteristics of becoming excellent physicians and were aligned with AOA's mission and values and the school's determination ("clerkship distinction").

# Clerkship Distinction

- Points for each clerkship will were awarded by:
  1. Top 50% of the Likert scale (ranking a student 1-5 based on clinical work evaluation in clerkship)
  2. Nomination from clerkship director for distinction in clerkship-nomination will identify medical students who demonstrate characteristics of excellent physicianship – trustworthiness, character, caring, knowledge, scholarship, proficiency in the doctor-patient relationship, leadership, compassion, empathy, altruism and service leadership.
- Application eligibility determined based on grades available at the time of selection (usually in May)
- Selection committee used rolled up scores of total number of points in category 1 clerkship points and category 2 clerkship points in the student's completed clerkships at the time of selection to generate a list of students in the top 25% and these students were invited to apply to AOA.





# Class of 2023 Medical Student Eligibility and Selection

- Students considered eligible for nomination for election were invited to apply. Selected students submitted an application to the LCOM AOA selection committee for a blind review
  - summarizing their scholarly, service and leadership work
  - an essay reflecting on their professionalism, leadership, service and scholarship.
- From this group, twenty percent of the total number of the class expected to graduate were elected to membership

# AOA and Diversity

- Membership in the Alpha Omega Alpha (ΑΩΑ) honor society is a widely recognized achievement valued by residency selection committees and employers. In **2017**, Dr. Boatright et al, published the below article which demonstrated that the AOA selection had favored students from racial/ethnic groups not underrepresented in medicine (not-UIM).
- Since this discovery, We have been working to create equity in AOA selection at LCOM by applying a series of strategic changes grounded in evidence on inclusion, mitigating bias, and increasing opportunity throughout the AOA selection process.

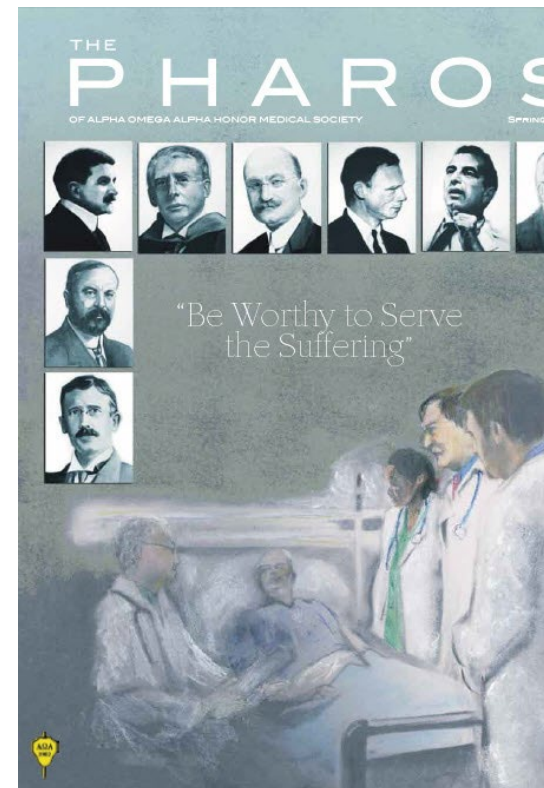

## Community-acquired pneumonia

The tyranny of a term

What signifies knowing the name, if you know not the nature of things?

—Benjamin Franklin

Picturize this. It's a true story.

A twenty-nine-year-old woman enters a hospital emergency room with complaints of fever and cough. In the emergency room her fever is confirmed, she has a cursory exam and is sent for a chest X-ray that shows a left mid-lung infiltrate (see the X-ray above). A diagnosis of community-acquired pneumonia (CAP) is made, and the patient is discharged on azithromycin.

She faithfully takes the antibiotic, but after a week is no better and returns to the emergency room. This time the chest X-ray shows expansion of the left mid-lung infiltrate and a new right upper lobe infiltrate. She is admitted to the hospital. What is the admission diagnosis? It's community-acquired pneumonia. After all, she has evidence of pneumonia, and it occurred outside of a health care setting, so it is, in fact, a community-acquired pneumonia. This time she is treated with moxifloxacin, and, after four days, she is stable and discharged

to complete her antibiotic course.

Two weeks later her fever and cough have not subsided so she returns to the emergency room. The infectious diseases consultation service is called to see her. They take a history! Among the information that is quickly obtained with just a few questions is the following: Her cough and fever had been present for almost two months before she made her first trip to the emergency room; she had lost nine pounds since the illness began; she had night sweats almost daily; and she resided in a recovery home for former drug users where another resident has had a bad cough for a few months. What is the diagnosis? Tuberculosis seems very likely. She is hospitalized, isolated, and a sputum sample has acid-fast bacilli and later grows *Mycobacterium tuberculosis*.

What should we make of this story? If one were to present the case of a patient with two months of cough, fever, night sweats, weight loss and a pulmonary infiltrate, any third-year medical student would consider the diagnosis of tuberculosis. Yet fully trained physicians missed the diagnosis on three occasions. Why? We believe it is the tyranny of the term "community-acquired pneumonia." All one needs is a cough, fever, and an abnormal chest X-ray and no further information is required. We have a diagnosis and a course of treatment. What could be simpler? Yet the hazards of this approach are obvious.

Language matters. The way we frame an issue, and the words we use to indicate it or describe it can dictate the way in which it is handled. The term CAP has eliminated thoughtful

# AΩA Award for Excellence in Inclusion, Diversity, and Equity in Medical Education and Patient Care

- Recognizes medical schools (and their associated AΩA Chapter) that demonstrate exemplary leadership, innovation, and engagement in fostering an inclusive culture that transforms the ideals of inclusion, diversity, and equity into successful programs that support medical student, house staff, and faculty diversity in service to the community. Clinical investigation, basic laboratory research, epidemiology, or social science/health services research
- Up to three awards will be presented each year. Recipients will receive a \$2,000 cash award to be used to further develop schoolwide and/or Chapter programs to support the school's or Chapter's efforts toward inclusion of under-represented minority students.
- All medical schools with an AΩA Chapter are eligible to apply. AΩA members included in the nomination packet must have active dues status in AΩA. Chapters that have received the award are not eligible to submit another application for three subsequent years.
