

VERMONT PESTICIDE CERTIFICATION GUIDE

Anyone in the state of Vermont who uses, supervises, recommends, or sells pesticides and/or trains Worker Protection Standard handlers/workers may be required to take and pass the CORE exam and all appropriate category exams to become certified. Certification is administered by the Vermont Agency of Agriculture, Food & Markets to ensure that pesticides are used in a proper and legal manner.

- Certification and exams are administered exclusively by the Vermont Agency of Agriculture, Food & Markets (VAAFM) <https://go.uvm.edu/vaafm-pesticide>
- Vermont uses study manuals from Cornell University (New York) for most categories.

Final Step: License & Costs

- You will be notified when you pass exams and what charges are due to receive your license.
- Private certification charge is \$25, valid for 5 years
- Commercial and Non-commercial certification charge is \$30 per category (\$120 maximum), renewed annually

Stay Certified: Recertification Credits

- All certified applicators have 5 years to earn recertification (i.e. continuing education) credits to maintain certification.
 - Private certification must earn 8 recertification credits
 - Commercial or Non-commercial must earn 16 recertification credits
- Applicators that have not earned the required number of credits must re-take the exams in order to remain certified.

- Recertification credits are earned by attending meetings and/or courses approved for credit by VAAFM

- NOTE: New England states have reciprocal agreement wherein any recertification credit approved and earned in one New England state will be accepted by the other New England states. It is up to the applicator to report to their state with proof of completion (usually a certificate). That state will then check back with the issuing state to verify that the event occurred and the attendance roster on record.
